CREW Naples-Ft. Myers, Inc.

General Membership: Application for General Membership in **CREW Naples-Ft. Myers, Inc.** is open to professional individuals who meet the following criteria:

1. Active employment in a "field of commercial real estate" as defined by CREW Network for a minimum of 5 years. The qualifying fields of commercial real estate are listed in the Area of Expertise Section on Page 2.
2. Two verifiable references within the commercial real estate industry. References are required to be from sources other than the applicant's current employer. Current CREW Members and/or Board Members are eligible references.
3. Attendance at a previous CREW meeting or function.
4. Submission of full membership fees at time of application.

Associate Membership: Application for Associate Membership in **CREW Naples-Ft. Myers, Inc.** is open to professional individuals active in the field of commercial real estate with more than 2 years' but less than 5 years of the applicable experience required for General Membership. Please note that Associate Members are non-voting members and are ineligible to serve on the Board of Directors. Associate Members will pay a discounted rate for annual dues, but shall actively serve on a minimum of one committee. Once an Associate Member has 5 years' experience, they will become General Members. The number of Associate Memberships may be limited in the discretion of the Board of Directors.

Candidate Membership: Application for Candidate Membership in **CREW Naples-Ft. Myers, Inc.** is open to professional individuals active in the field of commercial real estate with less than 2 years' applicable experience. Please note that Candidate Members are non-voting members and are ineligible to serve on the Board of Directors. Candidate Members will pay a discounted rate for annual dues, but shall actively serve on a minimum of one committee. Once a Candidate Member has 2 years' experience, they will become Associate Members. The number of Candidate Memberships may be limited in the discretion of the Board of Directors.

Affiliate Membership: Application for Affiliate Membership in **CREW Naples-Ft. Myers, Inc.** is open to any individual whose profession or experience does not meet the requirements of General, Associate or Candidate Membership. In addition to regular dues, Affiliate Members must pay an annual sponsorship fee of \$250 upon application and any subsequent membership renewal. Sponsorship dollars may be designated toward regular event sponsorship opportunities or special events sponsorship opportunities. The number of Affiliate Memberships may be limited in the discretion of the Board of Directors. [This requirement is waived should the Affiliate be a Platinum or Gold Partner, which includes Membership Dues and Sponsorship in the benefits.](#)

Student Membership: Application for Student Membership in **CREW Naples-Ft. Myers, Inc.** is open any individual of good character and reputation who is a student in a qualified field of commercial real estate. The number of Student Memberships may be limited in the discretion of the Board of Directors.

Retired Membership: Application for Retired Membership in **CREW Naples-Ft. Myers, Inc.** is open any individual who has been a General Member in good standing with **CREW Naples-Ft. Myers, Inc.** and who is no longer working full time, but wants to remain involved in the organization. Retired Members will pay a discounted rate for annual dues, may register at the member rate for programs and attend member only events; however, Retired Members are non-voting members and are ineligible to serve on the Board of Directors.

Civic Membership: Application for Civic Membership in **CREW Naples-Ft. Myers, Inc.** is open to any person whose profession or experience does not meet the requirements of General Membership or Associate Membership and usually includes Political, Celebrity and Academic. Please note that Civic Members are non-voting members and ineligible to serve on the Board of Directors. The number of Civic Memberships may be limited in the discretion of the Board of Directors.
